**Lodgement of Substantial Shareholding Notice 604 – CFS Retail Property Trust Group**

We advise that on 3 August 2012 the Commonwealth Bank of Australia ACN 123 123 124 (CBA) lodged a substantial shareholding notice (Form 604) in relation to the holdings in CFS Retail Property Trust Group (CFX) in error.


As a result of this error CBA has been overstating the Group's holdings in CFX since 31 July 2012.

The error was due to the double accounting of holdings for a member of the Group (The Colonial Mutual Life Assurance Society Limited). 66,088,722 units of CBA's proprietary holdings in CFX had been doubled up in the Group substantial shareholding reporting system. This can be attributed to the fact that until recently there has been no area within CBA that consolidated and accounted for CBA's on-balance sheet holdings that are held outside of the Group's accounting system.

We will be lodging a corrected substantial shareholding notice today which amends the previously announced holding percentage from 15.88% to 13.12%.

To prevent further occurrence of this issue, on balance sheet positions are now being reconciled periodically by a central team within the Group.
