## Westfield Group (ASX: WDC) – Request for trading halt

Pursuant to Listing Rule 17.1, Westfield Holdings Limited, Westfield Management Limited as responsible entity of Westfield Trust and Westfield America Management Limited as responsible entity of Westfield America Trust (together Westfield Group) request a trading halt to be applied to the stapled securities of Westfield Group from the commencement of trading on Thursday 29 May 2014.

The trading halt is requested pending an announcement of the outcome of the meetings of securityholders of each of Westfield Group and Westfield Retail Trust (ASX:WRT) in connection with a proposal to restructure Westfield Group and Westfield Retail Trust which are to be held on 29 May 2014 from 10.00am and 2.00pm, respectively. For the proposal to proceed, the securityholders of each of Westfield Group and Westfield Retail Trust must approve a number of interconditional resolutions.

Westfield Group is not aware of any reason why the trading halt should not be granted.
