## **Campbell Brothers completes 5 for 1 Share Split**

At the AGM held on 31 July 2012, shareholders approved a resolution authorising a share split of the issued capital of Campbell Brothers Limited (the Company) on a five for 1 basis.

The share split of the Company's securities has been completed and the Company now has 340,520,220 ordinary shares and 380,970 performance rights on issue.

The Company confirms it has completed the despatch of holding statements to security holders advising them of the split of their securities.

<u>Note</u>: On Tuesday, 21 August 2012, the Company's name will change on ASX to ALS Limited and the new ASX code will be ALQ (from CPB).
